Serving as a unique nexus between the profession and the pipeline of diverse attorneys, Ms. JD's online community provides a forum for dialogue and networking among women lawyers and law students. Ms. JD's programs provide law student fellowships, public interest scholarship and international scholarships for foreign women law students.
